"Beyond the Spill" Public Discussion



In our ongoing commitment to environmental justice, PRS 365 Limited partnered with Transparency International Zambia (TIZ) and the Zambia Environmental Justice Coalition (ZEJC) to co-convene a public discussion on 11 September 2025. The forum, which engaged over 120 stakeholders, focused on transparency, accountability and citizen action following the Sino metals tailing dam failure. A consensus emerged: for a just and effective path forward, affected communities must have a guaranteed seat at the decision-making table, backed by robust scientific evidence, unwavering transparency and clear mechanisms for accountability.
